About this report

This report contains information about all fees that are under the OAG’s authority.

The information reported includes fees that fall under the *Service Fees Act*.

The information covers fees set by contract, and the report provides totals only.

Although the fees charged by the OAG under the [Access to Information Act](#)³ are subject to the *Service Fees Act*, they are not included in this report.
